 - e. Treasurers Report
 - Typically, the club is close to "net zero" at the end of the fiscal season
 - This year, net income (from registrations) was down approximately 50%
 - However, net expenses were also down
 - Therefore, there is a net revenue of approximately \$20,000
 - a. Ideas:

 - ii. Give back a fall credit/refund
 - f. ADYSA (Boys/Girls Rep)
 - Parents asking about Spring and next fall
 - Official cancellation of BCCSL and Provincials
 - Charter clubs transitioning to Canada Soccer Quality
 - Input on ADYSA interlock (U8-U12)
 - BC Soccer has eliminated Metro for 2009 age group and younger
 - All older age groups 2008 and older are being grandfathered with the same system, including Metro
